### SUMMARY

This report has been prepared as a result of query by the District Council of Port Wakefield to the Director, Department of Lands, in regard to their future responsibility towards the building. The query was forwarded on to the Heritage Conservation Branch and this nomination resulted.

Historically, the Police Station and Court House are important because of their association with the first period of Port Wakefield's history when it functioned as the export port for copper ore from the Burra Mines. Although built in the year the copper teams (bullock and mule) were rerouted through Riverton to the new railway terminus at Gawler, thus by-passing the port, the reason for their construction was directly linked to the problems faced by the town during its "pioneering days".

Architecturally, the Police Station and Court House Complex is important as an early, and unusually austere, work of the Colonial Architect's Office (E.A. Hamilton). While the main building is a variation of a standard layout, the lineal arrangement of the complex is unusual. The building interior is in a bad state of repair but intact.

Environmentally, the Police Station and Court House Complex is important in maintaining the character of the street and the township.

The Integrity of the Police Station and Court House Complex is important as a basically intact example of this building type and its evolutionary development. While the condition of the building distracts somewhat, all of the details exist and the few alterations are obvious.

The Police Station and Court House Complex is on the National Trust Register as a Recorded Listing.

#### RECOMMENDATION

It is recommended that the Police Station and Court House Complex be included on the Register of State Heritage Items and that it be categorised A3, H3, 3.1.

Continuity: Built on the outside of a curving street, visually dominant, other houses and buildings of a similar simplicity, materials and scale. 10. Local Character: Port Wakefield is a dominantly single storey town in scale; town displays little frivolity in decoration or design, serious austere atmosphere. Position on curving street, lineal layout creates a large composition, simplicity somewhat counters its size, familiar local landmark.

15. Adaptation:

Within the context of its existing form and design, the complex has a very good opportunity for adaptation The number of rooms is quite large and their sizes vary enough to provide for a range of functions. The main elevations should be restored but minor alterations and upgradings internally should be

permitted.

16. Interpretation: The building has an obvious passive role in the town character but also has a high potential for an active

interpretative role. The District Council and others are considering this building for a museum.

17. Current Situation: The Police Station and Court House is owned by the Port Wakefield District Council. Although the building has not been well maintained and protected


