Supplementary Information

Adaptation: The building's external form and appearance should be maintained and restored. The interior may also be restored but this should not be mandatory as its originality is questionable. The trees in the grounds should be retained for a suitable setting for the cottage.

Interpretation: The cottage has a potential for an active interpretation programme but this should be viewed in light of other venues in Penola. At present the cottage's role is passive as a remnant of the past.

Current Ownership: District Council of Penola.

Item

History and Sources

Section 3 of the Hundred of Penola was purchased by Alexander "King" Cameron on 4/10/1850. The purchase price for the 80 acre section was £80/1/- and the Scottish pastoralist, whose home station was located about 2 miles south of Penola, established the township of Penola on the section around an inn built by him between 1844-1846.

Ulva Cottage, believed to have been one of the first built in Penola, is situated on allotment 49. The first transaction registered over the property occurs on 30.7.1861, when Cameron sold allotments 40, 41, 48, 49, 62, 63, 64, 65 and 66 to Andrew Watson of Kilbride and Allen Clarke Coleman, Storekeeper of Penola. The property was transferred a few years later to Albert James Edwards, a licensed victualler. Local sources state that Ulva Cottage was built by the Camerons for Dr. Baynton, one of Penola's first doctors and the husband of Margaret May Cameron. Council assessment books describe a cottage and garden in 1869, the year the District Council of Penola was formed. When an application to bring the property under the Real Property Act was made in 1889, the cottage was occupied by P.D. Nash, a storekeeper and H.G. Wells an inspector of sheep. It is now owned by the District Council of Penola. Plans for the extension of the nearby swimming pool will incorporate the cottage in the pool's surrounding area.

The cottage is an example of the type of dwelling built in the early years of the town's history and as a result reflects the period between 1850-1870 when the town became firmly established.


