## STATEMENT OF CULTURAL SIGNIFICANCE

This is a significant vernacular building because of its design and construction, even though it is not one of evident architectural distinction. It is also an item of great historical significance because of its identification with the development of the horse tramway between Goolwa and Port Elliot in the mid 1850s.

### Significant Interest

- **Historical** This is an item of great historical significance because of its identification with the building and early development of the tramway between Goolwa and Port Elliot.
- Architectural This is a vernacular building, and though not one of architectural distinction is certainly a distinctive one because of its design and detailing and is therefore an item of considerable architectural interest.
- Environmental The design and detailing of this building make it a distinctive element in Goolwa, though its location means that it is not a landmark.

## RECOMMENDATION

We recommend that the item should be included on the Register of the National Estate.

## ANALYSIS OF SIGNIFICANT INTEREST

HISTORICAL

Date 1852

'Work began on the Port Elliot and Goolwa railway on National Trust notes: 21 June 1852 and the foundations for the Railway Superintendent's House were laid in July 1852. National Trust Reg. No. 349 describes the building as 'In the form of a Tshape, the original section of the building is well constructed of limestone rubble, with massive roughly squared limestone blocks to quoins, gable stops and window surrounds. To the segmentally arched gables at the extremities of the T-shape, the windows have segmentally arched heads with unusual casement frames under. The heads are of shaped limestone and windows are small half-paned casements, under a transom with fanlight over. Above these windows are gable vents with stone surrounds. The copings to gables are of brick and the roof is of interest, for it is simply self supporting corrugated iron in semi-circular shape. There is no internal structure apart from ceiling hangers to support the lath and plaster ceiling. The interior retains cedar joinery to window, door and fire surrounds. Presently owned by the National Trust of South Australia, the building is being maintained and gradually restored by the caretaker. An underground tank with domed roof of brick exists at the rear. A pump is shortly to be reinstated to the tank in working order. Original thresholds are shaped granite'.

Work on the building was still in progress on 2 December 1853 when a Mr. Wilson was undertaking carpentry.

On 1 January 1854, Mr. Buxton Forbes Laurie was appointed as the first superintendent of the Port Elliot and Goolwa Railway. However, on 5 January of that year Mr. Laurie became the first district's Special Magistrate and Mr. Thomas Jones, C.E., took over the position of Engineer and Traffic Superintendent of the railway.

Research has not revealed the earlier residents of the house. Nevertheless, it has been understood that, on completion, the Lieutenant-Governor and his family occupied the 'cottage', as it was called, for three weeks whilst he was reviewing construction works and on other general administrative duties.

By 1878 the structure was designated as 'Govt. Cottage Occupied by Station Master'.

In the interim, organisational changes had taken place to the traffic-way. The Middleton-Strathalbyn railway had been opened on 23 February 1869. On 1 October 1884 steam locomotives were introduced on the Goolwa line. (The Adelaide to Victor Harbor railway line had been completely converted to steam by 1 April of the following year).

Under an agreement dated 1 September 1893 the house was rented by a Mr. J.A. Hewitt, an 'outside tenant' as other than railway employees were officially referred to, for 2/- per week. However, he vacated on 21 September 1894, and possession was immediately taken by Ganger Hurst at the increased rental of 3/- a week.

It would seem that the house was tenanted by railway staff until 1932, when the last employee was Ganger Litster.

On 23 May 1932, Miss Clara Hedding of Goolwa entered into an occupancy agreement at 8/- a week. It has been interesting to note that the fittings and fixtures were listed as: '5 Wire doors, 9 wire windows, 4 Mantle shelves, 4 cupboards, 3 Spring rollers, 1 copper, 1 Stove, 1 Douglas Pump & 6 Door Keys'. The payment was reduced on 11 January 1933 to a standard of 5/8d. plus 6d. for water. Miss Hedding lived in the residence until 18 October 1941.

Mrs. Muriel Stewart took over on the next 2 November at a weekly rental of 6/2, including the charge of 6d. for water. As the accommodation was required for Departmental purposes after World War II, Mrs. Stewart left on 2 July 1949. Maintenance work was immediately required such as the renewal of some lathe and plaster ceiling with caneite, the painting and kalsomining of the entire interior, the treatment with 'Boral' for floor borers and attendance to all the locks on the doors. Packer Arthur Stanley Forbes Arbon was the next tenant after Mrs. Stewart. Work for the provision of a bathroom and laundry commenced on 28 February 1950, and was completed on the following 18 April at an estimated cost of £162. Packer Arbon then had extra rent of

Between 27 February 1953 and 8 April next three window hoods were added, and the rental again increased, by a further 3d. per week.

After being vacated by Packer Arbon, the house was occupied by Mrs. I.M. Pratt from May 1961 - as a life tenant. When she passed away in January 1973 negotiations were entered into 'to dispose of House No. 120 at Goolwa to The National Trust of South Australia in accordance with Section 84(1)(a) of the South Australian Railways Commissioner's Act, 1936/71'. The sale was approved on 30 August 1973 and the contract with the Trust was in effect from 20 September of that year. In order to complete the legalities the transfer instrument was signed on 11 July 1974 by Mr. Complete the legalities and Mr. George Symes as Vice President of The National Trust of South Australia.

The Certificate of Title was issued on 23 August 1974.

Mr. and Mrs. F. Millward became the Trust's tenants and began undertaking a repair and renovation programme of the building, as well as establishing an outside garden and other external features.







The Railway Superintendent's Cottage is one of Goolwa's most significant and distinctive buildings. The dwelling was possibly Goolwa's first substantial building, and is historically important because of its association with South Australia's first railway, from Goolwa to Port Elliot.



Interpretive Panel, March 2005

Construction of the residence commenced in July 1852 and after its completion it was initially occupied by Mr Buxton Forbes Laurie, the first superintendent of the Port Elliot Goolwa line. He lived in the house for only a few months, after which Governor Sir Henry Fox Young used it briefly as a summer cottage.

Architecturally the limestone dwelling is of an unusual T-shaped design, with a curved, self-supporting, corrugated iron roof.




Side view and garden, March 2005




