Heritage Significance

Built in 1882-83 for Mr Frank Makin, 'Coreega' is an imposing two-storey sandstone dwelling standing in a quiet, secluded garden. 'Coreega' was the boyhood home of Sir Howard Florey, later Lord Florey, awarded the Nobel Prize for Physiology and Medicine in 1945 as the co-discoverer of penicillin.

Significant Interest

1. Historical: Demonstrates an intimate association with a person who made a notable contribution to history, i.e. Lord Florey, the eminent scientist.
  2. Architectural: Demonstrates exceptional merit in the construction and finish of this mid-Victorian dwelling.

## Analysis of Significance

### (a) Historical

'Coreega' has been a residence for over one hundred years. Originally the Victorian mansion was set in a 3.64 hectares garden but this has been reduced over the years to its present .56 hectare as land in the area increased in value and decreased in availability. Mr Frank Makin, the first owner, was a sharebroker who lived there for five years selling the property in 1888 to George Riddoch. In 1897 Frank Rymill and his family lived at 'Coreega' while additions were made to their own home 'Springfield House' situated to the north-east. In 1906, it was sold to Joseph Florey the Director of the Standard Boot and Shoe Company in Gawler Place. Joseph and Bertha Florey lived at 'Coreega' for nearly thirteen years, their son Howard Walter being eight years old when they moved into the home. Howard Florey was educated at St Peter's College and the University of Adelaide. In 1921 he entered Oxford University as a Rhodes Scholar. He studied in England and the United States of America in the 1920s and became Professor of Pathology at Sheffield University from 1931 for four years. In 1935 he was appointed Professor of Pathology at Oxford.

Florey was knighted in 1944 and in 1945 shared the Nobel Prize with Dr Ernst Chain for his part in developing the first antibiotic, penicillin, from a mould discovered by Sir Alexander Fleming in 1928. As a result of this work, pharmaceutical houses were able to manufacture penicillin in quantity during the latter stages of World War II.

From 1947-57 Sir Howard was adviser to the John Curtin School of Medical Research in Canberra. In 1960 he became the first Australian President of the Royal Society and was appointed Provost of Queen's College, Oxford, in 1962. Sir Howard was made a life peer in 1965 as Baron of Adelaide and Marston and was installed as Chancellor of the Australian National University in 1966. Lord Florey died at Oxford on 21 February 1968 and in 1969 Post-doctoral fellowships in biochemical sciences were launched in his name in both Australian and British institutions.

Florey was one of Adelaide's greatest sons and over the years 'Coreega' owners have had a sense of pride in the association of the house with the eminent scientist.

When Joseph Florey died in September 1918 his widow continued living at 'Coreega' for a year before selling the property to Mrs Antonie Wells and Mrs Rosa Stump. It was passed on to Mrs Stump's daughter Rosalind, the first wife of Mr Clifford Cornell. In the 1928 Springfield subdivision promotion booklet a plan of the Cornell property shows a 'large residence and ground', two tennis courts and an orchard or grove planted on the north side between the house and the hedge surrounding the old rectory of St Michael's Church.

In October 1951 'Coreega' became the joint property of Clifford Cornell and his second wife Mollie. Extensive subdivision was carried out during the next decade with Coreega Avenue being created as an access to the new blocks. After Clifford Cornell's death, Mollie Cornell purchased a smaller home at Urrbrae and put 'Coreega' on the market with one hectare of land. Howard and Jillian Guerin acquired the property in March 1975 selling it to Milford and Pauline Wardleworth two years later. Sidney Everett Pty Ltd owned 'Coreega' from March 1981 until the present owner Harley Hooper purchased it in 1986. The

house at present has approximately .56 hectare of land surrounding it with a long driveway to Fullarton Road. On the southern side it shares a boundary with Farr House now a private residence but formerly a Church of England Home for Girls, named after Archdeacon Farr.

(b) Architectural

'Coreega' is a substantial sandstone building with painted brick quoins and walls approximately 53 centimetres thick. The mid-Victorian house sits solidly within its leafy surrounds with an air of Tudor Gothic in the treatment of the entrance portico and the timber brackets to the upper verandah. This verandah has an open appearance with a simple timber balustrading replacing the earlier pressed iron and the original shingles. The ground floor verandah supports have a heavy cover of ivy and only the sequence of posts can be seen. The gabled ends on the north, west and south sides are all finished with louvred ventilation openings dressed to match the window surrounds.

The house is roofed in corrugated galvanised iron sheeting. The main chimney is an ornate mid-Victorian structure with four flues in a diagonal setting with a rendered brick base and classical cornice.

The portico entrance is tiled in a geometric pattern with slate steps leading down to the gravel driveway. The double front door features a Tudor-Gothic style arch with fan light and half side lights on either side. These windows are of stained glass and replace the original. Each door has two panels with deep collections. The sash windows are shuttered.

An arch supported on Corinthian columns in the entrance hall frames the magnificent stained timber curved stairway installed by the Floreys. Internal wall plaster is pointed to resemble stone blocks. The three rooms along the southern side flow together for entertaining. The drawing room has a wide bay window recessed on the interior behind a wide arch which is echoed in a similar arch over the fire place alcove. Another unusual alcove is placed east of the fireplace. Lit on three side by stained glass panels the recess has been used to display statuary and is a focal point for the grand salon. Ceiling roses, picture rails and skirting boards are all original as are the internal doors.

At the north-west corner a morning room/sitting room looks out over the sweeping lawns through French doors leading to the verandah. This room was originally the dining room with an adjoining butler's pantry with cupboards fitted to hold china, glass and silver wares.

Behind the stairs a small breakfast room with fireplace leads to the remodelled kitchen. A fully glassed conservatory extension to the kitchen has been recently constructed for family meals.

Upstairs the bedrooms are large and airy with views of the garden which was once part of the Adelaide Hunt Club's Mitcham run. The bathrooms have been fully renovated with fittings in keeping with the style of the house. A beautiful interior round arched window of stained glass is visible from behind stairs and from the central upstairs lobby onto which the bedrooms open.

The house has been beautifully and sensitively restored and refurbished and is a magnificent example of an Adelaide gentleman's mansion of the 1880s which has moved with ease and grace into the 1980s.

## SUPPLEMENTARY INFORMATION

### Representation on Register

Springfield is a charming suburb but its buildings are, on the whole, of fairly recent development. 'Coreega' represents the second wave of residential settlement of the area first established in the 1840s in the bushland foothills. 'Springfield House', the former 'Farr House' and 'Coreega' with St Michael's Church form a link which enabled later constructions such as 'Carrick Hill' (1938) to give a traditional quality to the area. Of these buildings only 'Carrick Hill' is Listed (6628-11509). It is important that the earlier examples be included on the Register of State Heritage Items.

### Integrity

The house has very high integrity being little altered in appearance. It has been slightly modified over the years particularly in bringing the service areas up to date in amenities. The grounds have been considerably reduced but still give a pleasant garden backdrop to the house.

### Circumstances

The building is used as a private residence by the owner, Mr Harley A.C. Hooper, a property consultant and developer. It was first nominated for the Register by the Heritage Conservation Branch in April 1982 and then by the City of Mitcham in May 1982. No action was taken at that time and the present investigation is in response to neighbours expressing concern over a proposal to subdivide one more block from the property with what they view as a threat to the existing mature trees within the grounds. The action, as at present proposed, will not detract from the heritage value of 'Coreega' and only one tree will need to be removed from the new site.

### DESCRIPTION

Substantial two storey sandstone building with painted brick quoins. Verandah to front elevation with simple timber balustrading. Corrugated iron roof with rendered and brick chimneys. Portico entrance is tiled with slate steps leading down to the driveway. Tudor-Gothic style arch over front door with fanlight and half sidelights on either side. Shutters to windows.
