Summary

This report has been prepared as a result of the Port Pirie National Trust expressing concern over the future of a number of buildings of Heritage Significance in Port Pirie. Located in Florence Street, the building is not under any immediate threat, but because of its location the building could be under development pressure in the future. The Heritage Conservation Branch have nominated this item.

<u>Historically</u>, the Waterside Workers Federation Building is significant because of its association with the labor unions which have contributed significantly to the listing of Pt. Pirie and characteristically reflect the industrial nature of the township.

Architecturally, the Waterside Workers Federation building is a finely detailed marriage of both Late Victorian and Edwardian style, its elaborate decoration symbolising the importance of Unionism in Pt. Pirie.

Environmentally, the Waterside Workers Federation building makes a significant contribution to the character of the surrounding streetscape, and is situated within a defined Heritage Area of Port Pirie.

The Integrity of the exterior of the Waterside Workers Federation building is high, however, the paintwork on the exterior stone facade and modifications to the shop fronts are not compatible with the original design.

The building is on the Classified List of the National Trust and on the National Estate Register. It is also included in the area identified as the Pt. Pirie Town Conservation Area listed in the National Estate Register.

Recommendation

It is recommended that the Waterside Workers Federation building, 50-51 Florence Street, Port Pirie, be placed on the Register of State Heritage Items and that it be categorized A2, A3, H2, H3.

HISTORICAL RESEARCH: W.W.F. BUILDING, 49 FLORENCE STREET, PT. PIRIE

The W.W.F. Building can be seen in the context of the growth of Port Pirie from a wool shipping port to a major industrial town, rivalling Port Adelaide in the latter half of the 19th century. In 1891, Port Pirie's population of 4,000 exhibited a large proportion of people between the 20-40 age group, with a preponderence of males. Ten years later, the figure had reached 8,000 with the demographic distribution stabilizing considerably. (Donley, 1975, 109). The growth of the trade unions between 1885-1896 reflected the predominantly working class nature of Port Pirie's population, which relied mainly upon smelting, railways and wharves for employment. B.H.P.'s decision to transfer smelting to the seaboard from the Barrier ensured the future pattern of industries in Port Pirie. Burgess, in describing the variety of societies in the township, commented in 1907 on the Amalgamated Workers Union as "strong in number, as well as in other respects" (Vol. 2, 508). The Australian Worker's Association, a Branch of the Waterside Worker's Federation, was inaugurated on June 8, 1901. Up until the first World War, membership of the former tallied over 800 but dropped to 540 by 1926 (Register, Sept. 18, 1926, Vol. 2, 24). The organization's books closed to membership after the W.W.I. "with the object of giving men engaged in the industry the opportunity to obtain a living".

Built by the Amalgamated Worker's Association, the building's foundation stone was laid in October 1911 by the Hon. John Verran, the **then** Labor Premier of S.A. Not long after its opening, the W.W.F. assumed control of the building and organised a Bakery and Co-operative Store in the two shops on the ground floor. The bakery was leased by the Union to private enterprise and the Co-operative Store operated until 1956 when it closed.

Both at a Local and State level the building's significance resides in its association with the organised Labor movement in Port Pirie and as a surviving example of an early 20th century building in the township which, for a time, rivalled Port Adelaide as South Australia's major port.



John Verran. At the time it was the headquarters of the Amalgamated Workers' Association whose members in Port Pirie had contributed 2s per week each towards the building fund (wages being 8s a day), enabling a block stretching from Florence to Gertrude streets to be aquired for the present building.

The building came under the control of Waterside Workers' Federation not long after opening. The W.W.F. operated a bakery and a co-operative store the former was leased to private enterprise and the latter closed in 1956.

The facade of this two-storey building boasts a covered balcony and verandah, supported on paired posts, spanning the footpath. The building's face is stuccoed sandstone rubble. The semicircular fanlight over the double six panelled doors is echoed in the verandah's central bay. Shallow segmental arches are used on the other bays. A sinuous pediment with some classical trimmings hides the roof from view.





SOUTH AUSTRALIAN HERITAGE ACT, 1978

Entry of Items on the Register of State Heritage Items

There has been an increased community awareness of the need to protect those buildings and features of our State which reflect our cultural heritage. The South Australian Government has recognised that awareness by passing the South Australian Heritage Act, 1978, for which the Minister for Environment and Planning is responsible. In accordance with the provisions of the Act, the Register of State Heritage Items is being compiled.

Where the Minister considers that an item (defined as any land, building or structure) that is not on the Register is part of the physical, social or cultural heritage of the State and that the item is of significant aesthetic, architectural, historical or cultural interest, then the Minister may enter that item on the Register.

Pursuant to the provisions of the South Australian Heritage Act, 1978, I, Don Hopgood, Minister for Environment and Planning and Minister for the time being administering the said Act, hereby give notice that I have entered on the Register of State Heritage Items and the items described in The Schedule hereunder.

Items listed in The Schedule were previously placed on an Interim List in accordance with the provisions of Section 15 of the South Australian Heritage Act, 1978. Excepting items owned by the Crown and those within the area of the corporation of the city of Adelaide, the remaining items listed in The Schedule are subject to Part V of the Planning Act, 1982. That Act requires that no development, including demolition, conversion, alteration of, or addition to any item, is permitted without the written consent of the relevant Planning Authority. Items within the area of the corporation of the city of Adelaide are subject to the provisions of the City of Adelaide Development Control Act, 1976.
