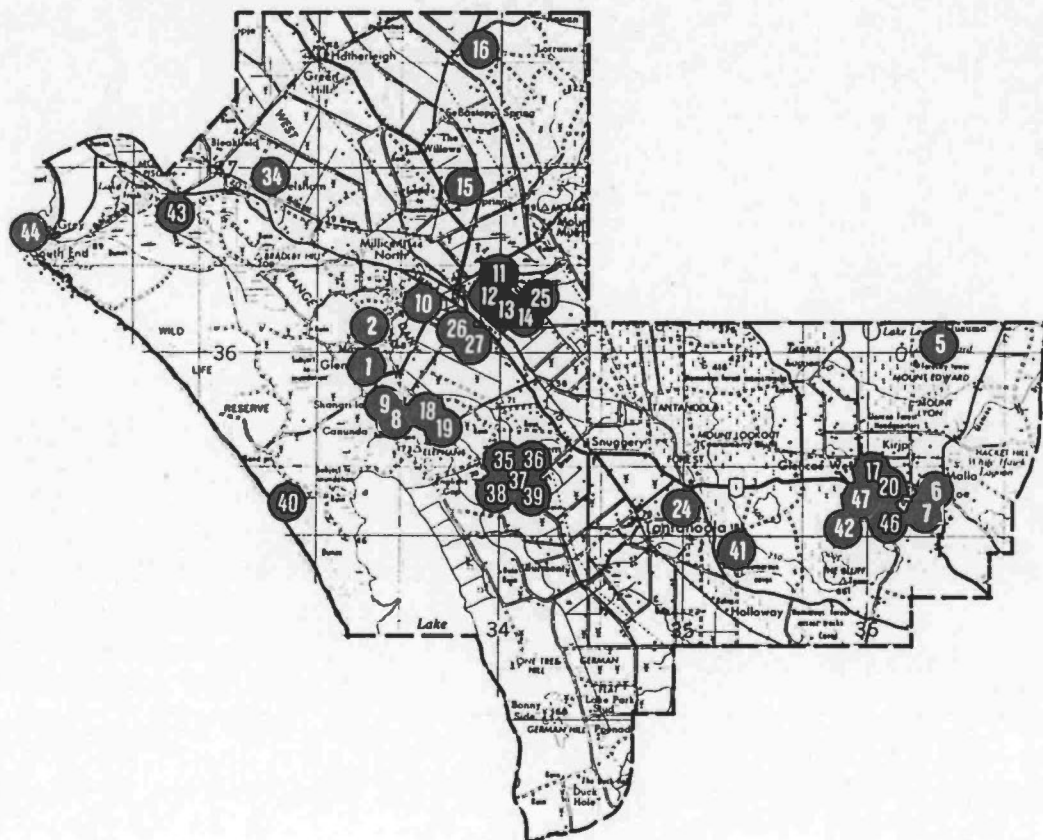

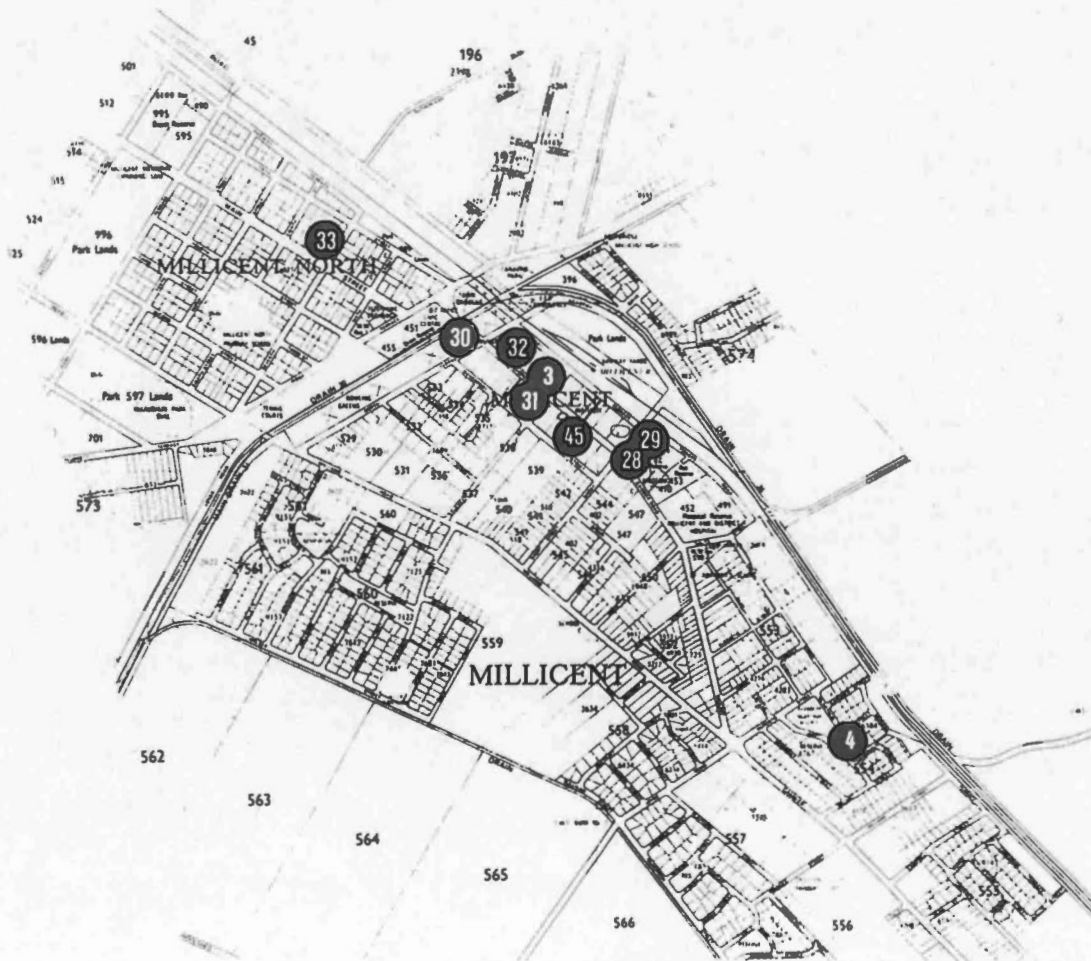

Description:

Random coursed stone vault, built into the hillside with a door at one end and a small 'elliptical' window at the other end. Timber lintel over door. Skilled stone cutting to shape vault.

The powder magazine was used to store explosives in connection with the beginnings of the South East Drainage Scheme. It is 'all that remains of the buildings from which operations were directed whilst drainage was in progress in the area' (Bruce Towers). Work on the drainage of the South East began in 1863, and during early years was under the supervision of Dutch engineer Butte.

Description:

Painted random coursed stonework with corrugated galvanized iron hipped roof and bull nose return verandah. Van Dieman's Land timber shingles under roof. Built on a foundation of lime concrete, excavated down to rock. Main rooms have French doors opening on to verandah, with keystone shallow arches. Split lath and plaster ceilings. Large cellars under house. The stone kitchen remains behind the house. Additions - c.1950.

The "Mayurra" run was pioneered by Samuel Davenport in 1845. He soon handed it over to his relative George Glen who built the homestead for his new wife Millicent, daughter of Bishop Short. After her the township of Millicent was later named. The materials and workmen for the building of the house were brought from Adelaide by sea and landed at Greytown (Southend). The domestic buildings were originally grouped around a courtyard. These included the kitchen, schoolroom and nursery.

Squared rubble walls with dressed stone quoins and rusticated segmental arches to double hung sash windows and doors with fanlights over. Large two storey entrance door with semicircular arched fanlight over. Cast iron lacework balustrade and posts to raked-roof verandah. Hipped corrugated galvanized iron roof, moulded chimneys.

Millicent's third hotel, built by the 'Millicent Syndicate' of White, McDonald and Sutherland. First manager was T. Secker of the Somerset Hotel.

Description:

Random coursed sandstone with Mount Gambier limestone quoins. 'M'-shaped corrugated galvanized iron hipped roof and return verandah. Double hung sash windows, some multi-paned. Random coursed stone lean-to extension on east side. Stone chimney.

'Woodgreen' was named after a place in England, where Mrs. Harris' family used to live. Mr. Harris was the first postmaster in Millicent in 1876 and Mrs. Harris was the daughter of Captain Davidson. Mr. & Mrs. Harris sold 'Woodgreen' in 1921 to a Mr. Simon for 3,000 pounds. In 1975, after a sequence of various owners, the house was sold to Miss F. Gower for \$14,000, who left it to the Millicent Branch of the National Trust.

Description:

Random coursed stonework with limestone quoins. Corrugated galvanized iron half hipped roof with fretworked barge board. Arched windows and doors with modern fanlights. Interior timbers for roof framing give an ecclesiastical appearance, using arched members. In some places the timbers are bow sawn, rather than adzed. Floor grating in sheep pens runs parallel to the shearing boards, which is incorrect. The shearing shed used to have 36 stands (18 each side). The total cost of building was 1,500 pounds. The shearers' quarters, at the rear of the shearing shed, used to reflect the style of the shed, but now have been converted into a hall and have lost any similarity.

Built for Edward Leake who, with his brother Robert, had founded the "Glencoe" station in the early 1840's. Later owned by John and George Riddoch, also great squatters. Up to 53,000 sheep per season were shorn in this shed.

Random coursed Mount Gambier limestone with a corrugated galvanized iron gable ended roof. Two storey building. Keystones over some openings, otherwise stone lintels. Possibly timber shingles remaining under iron. First floor level of gable end has a multi-paned double hung sash window. Stone walls form courtyard in front of stables with other stone buildings.

Built on a grand scale, like other stone constructions of the Leake Bros. in the 1850's and 1860's. The homestead, "Frontier House", has vanished.

Description:

Random rubble stone two storey building with single storey lean-to on one end. Corrugated galvanized iron gable ended roof. Stone fireplace and chimney within structure of wall of lean-to. Timber lintels over openings. Lean-to has raked roof. Upper floor has timber floor.

Built near the newly opened Milne's Gap drain, for the Osborne family who had been woolscourers and fellmongers in Leeds. Wool was washed in the drain and dried near the building. A second building nearby, on a more convenient site, was built in 1880. 'Scoured wool commanded a better price, and was cheaper to transport because all the dirt had been removed. Many hundreds of bales of wool were washed each season, the largest supplier being the Benara Estate of Mt. Gambier' (Bruce Towers).

Random coursed sandstone walls with white stone dressings. Red painted corrugated galvanized iron hipped roof with gable end. Corrugated galvanized iron bull nose verandahs. Elegant bay window to gable end. Part of the verandah built in with low stone walls and glazing. Built in three main parts, with the dining room being the latest section. The house includes cottages shifted from across the road and joined on.

Built for Peter Sutherland, of the family which acquired vast holdings in the region. The Sutherland brothers contracted for drainage and road-making works, then turned to the land. They were members of the Morambro Syndicate, which made huge land transactions. Peter was the first Chairman of the District Council of Kennion. House later owned by his daughter and her husband, Mr. & Mrs. Albert Varcoe, noted for horse-racing and philanthropy.

Kitchen - Random rubble stonework, using stones collected from the surrounding paddocks. New corrugated galvanized iron gable ended roof with small stone parapet walls. Timber lintel above stove. Chimney used some volcanic stones from Mount Muirhead.

House - Built in several stages using different architectural styles and construction. Main part of the house has a red dolomite front elevation with white pointing and Mount Gambier limestone quoins. Corrugated galvanized iron hipped roof with concave verandah. Double hung sash windows.

The kitchen was built by the Kealey family in about 1872. It was used for the first Catholic masses in the Millicent district and 'two Bishops have said mass in it'. The Kealeys made their property available for other activities in connection with the Catholic Church.

Front elevation has random coursed red dolomite stonework with limestone quoins, whilst the side elevation is constructed of local sandstone with limestone quoins. Corrugated galvanized iron hipped and gable ended roof with bull nose return verandah. Verandah has wrought iron balustrade and small gable adjacent to front entrance. Gable end on front elevation has a bay window. Alteration made to back of the house, enclosing the small verandah. Interior has large rooms with fine joinery, particularly in the main hall.
