<b>HERITAGE SIGNIFICANCE</b>  This large stone lined underground water catchment was constructed by the pastoral lessee, John Ellis (lease 124) prior to the resumption of the land by the government in the late 1860s. The area of 22 acres including the tank was dedicated as Water Reserve No. 2 in 1889 and later leased to the Cummins family, who settled on nearby land in 1871. The tank is of irregular shape and approximately 10 metres long and 2 metres deep. ## HERITAGE SIGNIFICANCE

Despite the lack of water in this area, pastoralists took up occupation from the 1840s, the first being Capt. John Ellis (1845). His lease 124 was a vast 251 square miles and was run from the head station at Barunga. This (the present homestead) was described by the Surveyor General, Goyder in 1864 as a "substantial 9 roomed stone house and cellar, newly built..." It was built in the early 1860s.

Nearby stone outbuildings built at the same time include a blacksmith and carpenter's shop (later trapshed and station store). The present stone shearing shed was built as shearers' quarters, permanent staff rooms, dormitory and dining rooms, during the 1880s.

When this and adjacent land was resumed and sold in and after 1869 most of it was bought by John Maslin and Robert Barr Smith and worked as one grazing property, called the Hummocks Station. The present homestead became the head station and Maslin's residence.

Sold in 1918 and resurveyed in 1920, the Hummocks Estate became one of the most successful soldier settlement projects after World War I.

## HERITAGE SIGNIFICANCE

This square ironstone tank was probably constructed by the pastoral lessee, John Ellis (lease 124) prior to the resumption of the land by the government in the late 1860s. John Ellis' head station "Bumbunga" was situated nearby on section 569. The tank is a landmark beside the Main North Road and an interesting relic surviving from the pastoral era of the district.



<b>HERITAGE SIGNIFICANCE</b> This large salt lake is a dramatic landmark lying near Highway One at Lochiel, with its unusual pink colouring and wide expanse. The shallow lake's potential as a salt site was recognised as early as 1868, although a lease was not taken up until 1881. This was worked by evaporation at the northern end of the lake (evaporation pans, furnaces, tank and men's quarters were located on sections 646 and 652). By 1883 production was 6 to 8 tons of salt per day. By 1910 there were at least 3 lease-holders scraping thousands of tons of salt when the lake dried up (usually December). The Australian Salt Company was established in 1913, with works north of Lochiel. The salt was refined at Pt. Wakefield. The Company, liquidated c.1922, was replaced by the present Australian Salt Company, formed in 1924. Since 1930 this Company has held all the lake leases and operates from the works established north of Lochiel by the original Company (little, if nothing of the original salt works survives). ## HERITAGE SIGNIFICANCE

The lake also has a long history of other uses, for example, there are fresh water wells all around the edge of the lake, which encouraged early pastoral settlement. Also of particular interest is the use of the island (near the top end of the lake) as a burial place. Mrs. Longmire (the publican's wife) who died in 1865 is reputed to be buried there and it was still in use in 1880. Mr. E. Thomas was told by his mother she went to funerals on the island (about 90 years ago). As horse and dray could not cross the salt, pall bearers had to carry the coffin, resting it occasionally on two chairs also carried along. About 1900 Mr. Thomas (aged c.10 years) found 14 depressions in the ground on the island, which he assumed were graves.



### HERITAGE SIGNIFICANCE

While the facade of this old hotel has been "modernized", the original building survives (the outside walls: the interior division walls of pug were replaced with stone and the hotel has been altered and extended frequently).

"Longmire's Inn" was for many years the only sign of civilization at this locality, having been licensed in 1863 by Hiram Longmire, officially known as the "Traveller's Home." Aptly-named, the inn was sited by Longmire at the intersection of two stock routes, which had been developed by use during the early pastoral era. It was also the intersection of tracks from Kadina to Clare and Port Wakefield to Crystal Brook and "many unscheduled calls were paid... by teamsters who were carting copper from Burra Mines via Salt Lake to Port Wakefield for shipping." The original inn contained 8 rooms, behind which was a store, stables and yard. When Lochiel was surveyed in 1869 these buildings were the only ones in the vicinity, and were chosen as the north-east corner of the town. The inn had been erected with permission on leasehold land, and so was now (1870) resumed and sold by the government. The name was changed to "Lake View Hotel" in 1909.

### HERITAGE SIGNIFICANCE

"Apparently, the need for such a building did not arise until the early 1900's, as a public meeting was not called until March 1909 to consider ways and means of erecting an Institute and Hall". This hall was built in 1910 by Martin Brothers of Kadina, and it was opened in 1911. The building is a typical small public hall, of limestone and brick, with several subsequent additions (including a section commemorating the State Centenary, in 1936, and a 1978 section).



## HERITAGE SIGNIFICANCE

The limestone and brick shop has retained its original form and doors and windows, and is a typical country general store, which has since its construction provided a wide variety of goods and services for the town.

The town of Lochiel was slow to start developing, and there was no general store established there until the 1880s. The present store was built in 1910 by J.H. Nicholls. As late as 1939 store provisions were brought by sea to Port Wakefield and then by road. A large cellar (to the north of the shop) was built for use as a butter factory by Nicholls around 1900.

The shop also acted as post office, telephone exchange and bank agency. "Almost everything that the early settler required was sold at the store".

The separate residence (on lot 11) was built for the store-keeper in 1902 by a Balaklava builder, M. Clements.

## HERITAGE SIGNIFICANCE

This small, typical State School was built in 1927 on donated land. It was located a short distance from its predecessor (see separate sheet), which had been privately built and was deemed too small, dark and ill-ventilated by school inspectors.

The third Sunny Hill school built, of stone and brick accommodated about 30 local children, but was eventually closed (in 1969) due to the declining rural population which has characterised the entire state.

## HERITAGE SIGNIFICANCE

This history of this building and the subsequent school building (see separate sheet) is a faithful reflection of the histories of the large number of small schools which were established in town and countryside not only in the Snowtown district but throughout the region. Generally classes were first held in private houses; they were then shifted to small schoolrooms often provided by the landowner; these in turn were succeeded by "proper" schools established by the Education Department, which, with declining attendances, were closed in their turn.

Mr. R. Cowley provided a room for a school at his farmhouse in 1895, which was named Sunny Hill School in 1896. He built this school room as a separate stone building in 1905. It has only two windows and was very dark inside. Despite this it was used as a school until the third Sunny Hill School was opened in 1924 (see separate sheet). 




