



Double fronted Mount Gambier limestone house, stone quoins, all painted. Gabled corrugated galvanized iron roof, partially enclosed raked verandah with gabled entrance at centre, topped with finial. Double hung windows at front, bi-partite pointed arch window to gabled end, larger renewed windows at rear.

Ceased to be a Presbytery in 1901 when a new one was built in Alexander Street. Now a private residence.

Two storey house on sloping site, of ashlar Mount Gambier limestone. Steeply pitched corrugated galvanized iron roof with scalloped barge board. Simple undressed windows of one, two or six panes. Bay window at front with steep coffer roof.

In 1881 a schism occurred in Mount Gambier's Church of England, ostensibly over management of the choir, and the breakaways built their own Church of the Holy Cross in what is now Doughty Street, with a manse opposite. Rev. Hartley Williams, the first incumbent, ran a 'progressive' High School in his residence. The schism ended in 1893. The Church has gone, but the manse remains, having been in intervening years a nursing home. It is now a private residence.

Stone multi-gabled building with dressed stone quoins and surrounds to wide semicircular arched windows. Corrugated iron roof with overhanging eaves and cantilevered raked verandah surrounding building. Mostly painted. This railway station has similar characteristics to the old Penola Railway Station and the Bordertown Railway Station.

The town's first Railway Station was built in 1879 when a line was opened to Beachport. The link with Naracoorte (and hence to Adelaide) came in 1887. The current Railway Station was built soon after the opening of the line to Portland.

Double fronted building of random rubble with dressed stone parapet wall concealing hipped corrugated galvanized iron roof, dressed stone chimneys Quoins surround front door, pairs of double hung windows at front and single-paned double hung windows at sides. Hood mouldings above side windows. Pediment above central door supported by rusticated pilasters. Double curved verandah roof recently replaced by straight raked verandah and galvanized tube steel posts.

Local government began in Mount Gambier in 1863. Considerable unhappiness on the part of ratepayers caused a division into West and East Councils in the following year. In 1876 a third local government body was formed as the Mount Gambier Municipality.

T-shaped building of rock-faced dolomite with dressed stone quoins to corners and openings. Paired vent openings in gabled wall, gabled corrugated iron roof with timber finials. Concave corrugated iron verandah surrounding main entrance doors.

After the Blue Lake had been selected as being the most suitable source, ratepayers agreed in 1880 to a water scheme. Work began in 1882 on an underground reservoir, waterworks and pumping plant. The Pumping Station was completed October, 1884. At first 11 miles of mains were serviced in the town, but there have been several additions to the water scheme since, including enlargements of the Pumping Station.

Alexander Mitchell transferred the licence of John Byng's Mount Gambier Hotel, the town's first, to this building. Mitchell died in 1864, and for three years his widow held it as one of her numerous properties. William McKay bought it in 1867 and added a western wing, to which a second storey was added in 1883. The South Australian Brewing Company added the balcony in 1902. Fred Gifford held it from 1923 and made many alterations.

Two storey hipped roof building. Coursed random rubble walls with rusticated quoins. Semicircular arched doorways with fanlights over, segmental arched double hung windows. Raked galvanized iron verandah with cast iron lacework and balustrading to balcony, supported by pairs of slender cast iron posts. Addition to south exhibits two storey arched colonnade of Mount Gambier limestone.

Built on the site of John Byng's 'Mount Gambier' Hotel, the first in the town. Johannes Matthies Jens had run the Port MacDonnell and Globe Hotels. In 1884 he opened the establishment which took his name, and presided over it till his death in 1915. 'Over the years, a number of major alterations have made this hotel one of the leading country hotels in the Commonwealth.' (L. Hill). Enlargements were made in 1904, when the architect was W.R. Allison, and 1927, when Ritchie of Melbourne was the architect. Lock Bros. built the 1927 extensions; the columns were turned in one piece on a homemade lath, a feat thought impossible.

After much controversy over expense and choice of site, the Town Council moved from a weatherboard hut to this impressive building. Thomas Chute Ellis of "Benara" donated a tower and clock in 1883.



Hastings Cunningham donated land for a school in 1856. Two early slab schools caused much dissatisfaction, and tenders were called for a stone school and residence on the Cunningham site. At the time of opening it was the finest educational building in the South East. It was also one of the first buildings in local limestone. Methodist services were held in this building until the first Chapel was erected. Other churches used the house, as did the Show Society and the police for court cases. It closed in 1877 when the Government Public School was to open; it became a cordial factory, then a private residence. 'Possibly the second oldest building still standing in Mount Gambier' (National Trust). It 'must be one of the most notable structures in the South East of South Australia.' (L. Hill).
